# TRANS SEX WORKERS RIGHTS ARE HUMAN RIGHTS

The project "TransR-Trans Sex Workers Rights are Human Rights" seeks to contribute to the full exercise, acknowledgement and protection of trans sex workers' (TSW) fundamental rights.

According to evidence, trans communities still struggle to achieve equal rights and they often experience an environment that is less respectful towards them, with high levels of violence and discrimination, namely in the European contexts. Within this community, the group of trans sex workers is particularly vulnerable to social and public health harms.

The TransR project suggests concerted actions that focus on TSW but also on the circumstances and key-actors that prevent TSW from improving their physical and psychological health. Hence, this project aims to:

- Increase informed and effective interventions for TSW;
- Favour a more respectful environment for trans people in general and TSW in particular;
- Improve TSW access to healthcare, legal and social support;
- Encourage TSW empowerment and participation;
- Improve skills among professionals and stakeholders who play a crucial role in TSW lives;
